# BECOME A REVIEWER FOR FYSB APP



The Family & Youth Services Bureau's (FYSB) Adolescent Pregnancy Program (APP) is now recruiting panelists to support the evaluation of FY 2021 federal grant applications!

### Qualifications:

- Must be a professional with human services or public health experience, to include: provision of abstinence, contraceptive, sexual risk avoidance or other prevention education services for vulnerable youth; understanding of APP program and evaluation designs, and/or a student pursuing a degree in a human services field.
- Must have strong organizational and time management skills.
- Must be able to analyze and evaluate complex materials.
- Must have strong writing and editing skills.
- Must be comfortable participating in a virtual team environment.
- Must be available to participate in mandatory training webinars.
- Must have ability to effectively utilize the internet and web-based technology.
- Must be fluent in writing and speaking in English.
- Must be committed to the review process for the time frame allotted and any additional days as needed.

### Tools Required:

- Email
- High Speed Internet
- Telephone
- Windows or Mac-based interface
- Adobe Acrobat or other PDF reader

### Level of Commitment:

- Participate in approximately two (2) mandatory training sessions.
- Devote a minimum of 6-8 hours daily over a period of two weeks to read, evaluate and score applications.
- Devote 3-4 days for panel consensus discussion, if necessary.
- Be available a minimum of 4 hours between 9am (EST) and 5pm (EST) for the consensus discussions.
- Be on call or available on short notice during the process.
